RESOLUTION NO. 06-253

A RESOLUTION CONVEYING CERTAIN RIGHTS OF THE CITY OF PARKER TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION, CONSISTING OF A CONVEYANCE OF ALL RIGHT, TITLE AND INTEREST OF THE CITY OF PARKER IN AND TO AN EASEMENT AND THE PROPERTY DESCRIBED THEREIN; REPEALING PRIOR RESOLUTIONS OR PARTS THEREOF TO THE EXTENT OF A CONFLICT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the State of Florida Department of Transportation proposes to construct or improve State Road No. 30 (Business 98), Section No. 4154751, in Bay County, Florida;

WHEREAS, the City of Parker, Florida ("City") holds an interest in and to certain land by virtue of an Easement for Construction and Maintenance of Pipeline dated October 15, 1971, recorded on June 12, 1972, at Book 373, Page 681 in the Official Records of Bay County, Florida ("Easement");

WHEREAS, it is necessary that the Easement be acquired by the State of Florida Department of Transportation;

WHEREAS, said Easement and property described therein are not needed for City purposes; and

WHEREAS, the State of Florida Department of Transportation has requested the City to execute and deliver to the State of Florida Department of Transportation a quit-claim deed in favor of the State of Florida Department of Transportation, conveying all right, title and interest that said City has in and to said Easement and the land described therein required for transportation purposes and said request having been duly considered.

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF PARKER, FLORIDA AS FOLLOWS:

1. The City shall quit-claim, transfer and convey to the State of Florida Department of Transportation all right, title

and interest of Parker, Florida in and to said Easement and the land described therein to be used for transportation purposes in the public or community interest and for public welfare with such Easement and land therein not being needed for City purposes. Such quit-claim, transfer and conveyance shall be for consideration to the City of \$0.00.

2. The Mayor is authorized and directed to sign a Quit-Claim Deed, or any other appropriate documents, in favor of the State of Florida Department of transportation conveying all right, title and interest of Parker, Florida in and to said Easement and the land described therein.


3. A copy of this Resolution shall be forwarded forthwith to the State of Florida Department of Transportation.

4. This Resolution repeals prior resolutions or parts thereof to the extent of a conflict.


5. This Resolution shall be effective immediately upon passage.
