1. Culvers Development

Brian Maytum - Culvers

Brian Matum answers questions from committee regarding Culvers Development

Ms. Hutto provides a motion to approve the development with standard conditions and a stormwater provision with Mr. Robicheaux seconding. The committee unanimously votes to approve the motion.

A discussion ensues regarding proprietary information provided to the committee regarding the Culvers development and the development order process.

2. Gilstrap Property Division

Capital Holdings - owner of the property

Claude Elins works with the engineer

Mr. Elkins provides new renderings for the property. Capital Holdings states the plan for the property split. A discussion ensues regarding the land development rules for property split. Mr. Sloan asks for clarification. Capital Holding asks for information related to development orders and storm water issues. Chairman Rega explains the process and requirements. Mr. Sloan provides additional guidance.

3. Suggested wording of light manufacturing addition to the LDR (land development rules) – Robicheaux

Mr. Robicheaux presents the information regarding the light manufacturing addition to the land development rules. He states that this is the third time the committee has discussed this.

A discussion ensues among the council regarding the processes and requirements for light manufacturing as well as definitions. Mr. Robicheaux states that he will send the final changes to Mr. Sloan. Mr. Sloan explains the ordinance process.

Inquires as to other manufacturing businesses

Asked for clarification for what constitutes manufacturing

Has concerns for CRA-1 if it is opened up to light manufacturing

Has concerns about leaving decisions to the council regarding the CRA-1

Asks about purposes of change and PSI

Asks about intentionality of sub area 1 text change

4. Discussion of parking requirements for unique businesses as an addition to the LDR (land development rules) – Chairman Rega

Chairman Rega presents his findings related to parking spaces and numbers of anticipated employees as well as the designations of light industrial uses and heavy industrial uses. Chairman Rega makes recommendations for parking spaces for Parker businesses. Mr. Haney asks for clarifications. A discussion ensues among the council. Mr. Sloan expresses concern over basing parking requirements on the number of employees. Mr. Haney asked for clarification on types of parking for employees. Mr. Robicheaux suggests that Parker utilize 2 per 1,000 square feet for light manufacturing if retail is not present. Mr. Sloan suggests that Mr. Robicheaux's recommendation would be appropriate.

Audience Input for Agenda item #3

Diane Coates 1521 Dover Road

Expresses concern that a new business purchasing an existing business may require more parking spaces and how will the city address this issue

Can a developer be required to place parking in the back of their business

5. Voting for Chairman and Vice Chairman positions

Ms. Hutto makes a motion for Chairman Rega to remain as chair with Mr. Stryker seconding. The council unanimously votes to approve the motion.

Ms. Hutto makes a motion for Mr. Robicheaux as vice-chair with Mr. Haney seconding. The council unanimously votes to approve the motion.

Ms. Hutto thanks Mr. Robicheaux for all his hard work. Mr. Robicheaux clarifies why he provided a ballot to the city clerk. He suggests that the city council may wish to utilize this.

Mr. Haney thanks the committee for their hard work for the city of Parker.

Chairman Rega asks that materials for the planning agenda be provided to the city clerk at least 7 business days prior to the meeting.

Mr. Stryker makes a motion that materials for the planning committee meeting be received by the city no less than 7 business days prior to a meeting to allow for proper analysis of documents with Mr. Haney seconding.

The committee votes unanimously for the motion.

Mr. Robicheaux asks about terms of office.
