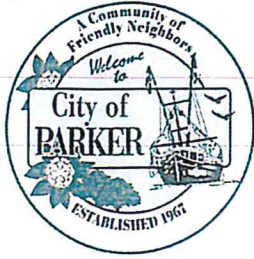


## ADJOURNMENT
