# PUBLIC HEARING – PRESENTATION OF THE FINAL BUDGET FOR FISCAL YEAR BEGINNING OCTOBER 1, 2023

#### 1. Public Announcement - Ad Valorem Tax Rate (Trim Notice) - Clerk

Pursuant to Section 200.065(2)(e), F.S., "Notice of Tentative Property Taxes for the City of Parker, Florida" (TRIM NOTICE) the proposed ad valorem rate for the Fiscal Year 2023/24 was advertised to be a maximum of 3.8000 mils. This millage rate would be greater than the current years rolled-back rate of 0.0000 mils. After reviewing revenue projections and proposed expenditure levels for the 2023/24 Fiscal Year, the General Fund budget is balanced at a tentative rate of 3.000 mils, which is more than the current year's rolled back rate by 3.0000 mils, an increase of 3.000. This means 3.000 mils is to be levied to fund fiscal year 2023/24 budget.
